Privacy Policy

All hard copies will be destroyed using appropriate destruction methods when no longer required.

Access to personal information we hold will be restricted to employees, contractors and associates of our business, unless you have agreed otherwise and will be kept for an indefinite period unless we determine we no longer require the information. Your personal information will be used to provide for the specified purpose it was collected. Should we provide your personal identifying or contact information to a third party outside of our organisation outside of the permissions contained within this policy and other terms agreed by you, we will notify you prior to this occurring.
